Dear Friends, Partners and Donors of United Way of Kern County,

What a year this has been! 2020 will never be forgotten. There were too many loses; in my case, I had to face the worst experience of my life with the loss of my 20 year old son Sebastian right at the beginning of this crisis. A year like no other for many of us who struggle with grief everyday of our lives. Yet, we seem to have managed to be on our feet, concluding this year and still standing in the middle of a pandemic which continues to destroy families, business and communities. What we have in front of us is not easy to see,

what we left behind is not easy to admit, but what we have in the present is our lives and our hope for better times. Our FAITH has brought us together, and together we have become stronger in Unity and Spirit.

It has been 3 years since I joined this organization, and the wins are too many to list here. Therefore, 2020 shouldn't be identified as a year of loss; on the contrary, due to its hardship our wins have been even bigger and more significant than

With our \$1.3 Million dollar donation from an anonymous donor, sponsors such as No Kid Hungry, and the help from our community who generously donated via our helpkern.org relief fund, we were able to accomplish many wins:

- 60,000+ meals distributed in 30 days during the summer, in partnership with the Bakersfield Marriott
- \$350,000 distributed in individual financial assistance to those affected by COVID-19
- \$300,000 distributed to agencies who were impacted by COVID-19
   Over 55,000 PPE distributed in the county
- Over 3,400 backpacks with school supplies were distributed in East and South Kern
- 2,000 meal distribution in partnership with the Vineland School District
- Over 600 grocery gift cards distributed to rural families in need during the holidays

These kinds of projects were not part of our programs, but we had to step up and do what was right for our community. Our highly affected underserved communities in the rural areas, senior centers, agricultural fields and economically disadvantaged school districts were in need, and we there for them. Many organizations came afloat and enthusiastically collaborated with UWKC to fulfill our mission. Kern County continues to be an amazing giving community, from individuals to large corporations.

Life has given us all an opportunity to sculpt a better version of ourselves, and I strongly believe we have done such. The work is never over, just as social justice will never be completely accomplished, but our path has been redefined and new light is quiding us.





#### **BOYS WITH A PURPOSE, GENTLEMEN'S CLUB**

This year UWKC had the honor of partnering and supporting College Heights
Elementary School students and their 'Boys With A Purpose, Gentlemen's
Club'. The purpose of this group is to teach young men how to dress, conduct
themselves like gentlemen and find their purpose in life. They are also taught life and
social skills which will help these young men build character, integrity and self-respect. The
primary objective of this project, which aligns with United Way's mission, is to raise a child in such
a way that our community and culture are strengthened. Project Objectives include but are not limited to:
provide field trips to universities to promote higher education, offer dress needs (such as: shirts, pants, belts, ties, etc.),
provide motivational speakers and furnish necessary items to students who need basic school supplies.

## FAMILY LIFE EDUCATION | 9 SCHOOLS | 6,678 KIDS

With the partnership of Bakersfield City School District, we provide Family Life Education to middle schools within the district.

Students receive comprehensive Sexual Health Education and HIV prevention education from our trained instructors, utilizing Positive Prevention Plus evidence-based curriculum that complies with the California Healthy Youth Act.

#### **CENSUS 2020**

United Way of Kern County was part of the Census 2020 Valley Taskforce receiving \$55,000 in funding for Census Outreach. 265,803 impressions were made through flyer distributions, individual phone calls and personal interactions. To promote participation, our team created events such as a "family set of 4 bicycles" Giveaway and a "Chalk Art" contest. UWKC participated in hard-to-reach areas and collaborated with over 10 different entities to fulfill the outreach initiatives. The amount of data collected is important because it's used to determine how dollars will support our community services and schools over the next ten years.

## HOME EMERGENCY AID PROGRAM (HEAP) CALIFORNIA EMERGENCY SOLUTIONS & HOUSING (CESH)

UWKC serves as the Administrative Entity of the CESH and HEAP. We have funded over \$600,000 to help homeless individuals and youth overcome financial barriers that would prevent the individual and youth from entering or maintaining housing.
